Friday, May 4 - Saturday, May 5, 2018**

\*Applications will be accepted through Friday, May 4, 2018, **providing space is still available.**  
Spaces are assigned on a **FIRST COME, FIRST PAID BASIS.** Spaces are 10' x 10' and fees are non-refundable. Event is Rain or Shine.

**\*PLEASE REVIEW VENDOR FEES AND ELECTRICITY INFO BELOW! \*CHANGES HAVE BEEN MADE FROM YEARS PAST.**

**CRAFT VENDORS:**

- \$75 for applications received on or before April 13, 2018
- \$85 for applications received April 14 – April 27, 2018
- \$100 for applications received after April 28, 2018
- \$20 Optional Electricity Fee - per 10'x10' space. **\*Electricity is limited and not guaranteed. Electricity should be paid for in advance when submitting your vendor application. You will be notified if you receive electricity and refunds will be given to those that do not receive electricity. Vendors are limited to 1 electrical outlet per booth space purchased.**

**NON-COMMERCIAL FOOD VENDORS:**

**Non-Commercial Food Vendors** are defined as non-profits, churches, and other organizations raising money for a cause or organization.

- \$75 for applications received on or before April 13, 2018
- \$85 for applications received April 14 – April 27, 2018
- \$100 for applications received after April 28, 2018
- \$20 Optional Electricity Fee - **Electricity is available, but very limited for non-commercial food vendors only. Electricity will be assigned on a first come, first paid basis and is not guaranteed. Use of any and all appliances must be approved by the booth coordinator and must be listed below.**
- Food Vendors are responsible for any food permits required by the State of Texas. You may sell non-commercial drinks (i.e. tea, water, lemonade, etc.) Food items should be unique to each booth and all items sold **MUST** be approved by the Chamber Booth Coordinator.
- **Chamber has all exclusive rights to sell soda products, hot dogs, & sausage wraps. Food vendors may not sell these items.**

**COMMERCIAL FOOD VENDORS:**

**Commercial Food Vendors** are defined as food trucks, trailers, or businesses that profit from their sales. **ALL COMMERCIAL FOOD VENDORS ARE REQUIRED TO GIVE 10% OF FESTIVAL PROFITS BACK TO THE LEXINGTON CHAMBER.**

- \$75 for applications received on or before April 13, 2018
- \$85 for applications received April 14 – April 27, 2018
- \$100 for applications received after April 28, 2018
- **COMMERCIAL FOOD VENDORS ARE REQUIRED TO SUPPLY THEIR OWN GENERATOR AND ARE NOT REQUIRED TO PURCHASE ELECTRICITY USE FROM THE CHAMBER.**
- Food Vendors are responsible for any food permits required by the State of Texas. You may sell non-commercial drinks (i.e. tea, water, lemonade, etc.) Food items should be unique to each booth and all items sold **MUST** be approved by the Chamber Booth Coordinator.
- **Chamber has all exclusive rights to sell soda products, hot dogs, & sausage wraps. Food vendors may not sell these items.**

**ENTERTAINMENT VENDORS:**

**Entertainment vendors** are defined as FOR PROFIT entertainment companies and amusement companies. **ALL ENTERTAINMENT VENDORS ARE REQUIRED TO GIVE 10% OF FESTIVAL PROFITS BACK TO THE LEXINGTON CHAMBER.**

- \$75 for applications received on or before April 13, 2018
- \$85 for applications received April 14 – April 27, 2018
- \$100 for applications received after April 28, 2018
- **ENTERTAINMENT VENDORS ARE REQUIRED TO SUPPLY THEIR OWN GENERATOR AND ARE NOT REQUIRED TO PURCHASE ELECTRICITY USE FROM THE CHAMBER.**

**VENDOR HOURS:**

**Friday, May 4, 2018 (OPTIONAL):** Your booth may open at 5:00pm (*there is a high demand for open booths during evening hours*)

**Saturday, May 6, 2018:** Booths should be set up and ready for sales by 9:00am. Vendors are encouraged to stay open through the evening hours as well, but may shut down after 5:00pm.

Vendors are asked to be equipped with their own display equipment including tables, chairs, canopy, and heavy-duty extension cords if electricity purchased. **ALL CANOPIES MUST BE SECURED.** We reserve the right to bar any duplicate sales or any craft items deemed offensive or in poor taste. You are responsible for your own tax status and for collecting and reporting sales tax where applicable.
